We, the undersigned trustees, certify that the taxpayers of School District No. 8 of Meagher County, State of Montana, on 14th day of June, 2011, voted on the following proposition:

PROPOSITION
June 14, 2011


Shall the high school district be authorized to impose an increase in local taxes to support the general fund in the amount of \$20,266.47 which is approximately 2.76 mills for the purpose of general maintenance and operations. Passage of this proposal will increase the taxes on a home with a market value of \$50,000 by approximately \$2.18, on a home with a market value of \$100,000 by approximately \$4.37, and on a home with a \$200,000 by approximately \$8.74. The additional limit of the levy is permanent once approved by the voters, assuming the district levies that amount each year thereafter. However, lowering over-Base tax levies in any year will lower the amount of permissively over-Base levies in subsequent year.


Shall the Elementary school district be authorized to impose an increase in local taxes to support the general fund in the amount of \$ 31,138.95 which is approximately 5.50 mills for the purpose of general maintenance and operations. Passage of this proposal will increase the taxes on a home with a market value of \$50,000 by approximately \$4.35, on a home with a market value of \$100,000 by approximately \$8.71 and on a home with a \$200,000 by approximately \$17.41. The additional limit of the levy is permanent once approved by the voters, assuming the district levies that amount each year thereafter. However, lowering over-Base tax levies in any year will lower the amount of permissively over-Base levies in subsequent year.


